IMPORTANT INFORMATION

Please read this information before completing the application form:

Dogs Queensland Accredited Breeder Scheme promotes good breeding practice. If you are considering joining, there are requirements that you must agree to follow. In return, you will be granted "Breeder Accreditation" endorsement from Dogs Queensland. You will be able to distinguish yourself as an accredited breeder and use the logo when promoting your litters and advertising on the Dogs Queensland website.

ACCEPTANCE OF ACCREDITATION

All applications will be fully considered when the requirements have been received by the office.

COMPLIANCE WITH COMPULSORY REQUIREMENTS

Compliance with some scheme requirements may be checked automatically by computer whenever an Accredited Breeder applies to register a litter. A survey is sent to new puppy owners and helps establish Accredited Breeder compliance with aspects of the scheme that are not able to be checked by computer. Random checks on compliance by the Accredited Breeder may be made by contacting a new puppy / dog owner. Any issues arising from a compliance check will be followed up and may require remedial action by the Accredited Breeder.

SITE VISITS

You must agree that your premises may be subject to a site visit. If there are issues of concern arising from a visit and it is considered that the facilities fall short of the standards expected for an Accredited Breeder, then this may result in the breeder being removed from the scheme. Complaints may be investigated using normal grievance procedures followed by Dogs Queensland. A breeder may be suspended from the scheme pending the conclusion of the investigation. During suspension, the breeder will not be able to use the privileges related to the scheme.

COMPULSORY REQUIREMENTS

1. I agree to comply with Dogs Queensland Rules and Regulations, Code of Ethics, ANKC Code of Ethics and the current ANKC National Code of Practice for Hereditary Diseases and all Local Government Legislation requirements (some of these criteria may be contained in the Self Evaluation Checklist).
2. I agree to comply with all the criteria and supply a completed Self Evaluation Check List form.
3. I have supplied the letter of reference from my veterinarian on the supplied form.
4. I have supplied two (2) letters of reference from previous puppy purchasers.
5. I have supplied a reference from another breeder (may be a registered breeder from Queensland or another state or territory).
6. I am able to provide evidence of previous voluntary and / or mandatory health tests for my breed(s) if requested.
7. I agree to have my Breeder's Prefix listed in the Dogs Queensland Breeder's Directory (Dog World and Website). If my Prefix is not currently listed, I will complete a Breeder's Directory Form (available from the Dogs Queensland Website) with this Application for Accreditation to enable my Prefix to be added to the directory (a discounted rate of 50% applies for part-year applications).

Please complete the application form and provide and attach the necessary requirements to the form.
